
The fund is a high risk, high return fund and should be invested in as a complementary investment to any long-term blue-chip portfolio.

The final month of 2017 unfolded with the news around global furniture retailer Steinhoff. The impact was felt across the bourse with a broad selloff and a resultant impact on overall liquidity. Although the fund has no direct exposure to Steinhoff, it does maintain a holding in KAP, which is held by Steinhoff. We took the decision to remain prudent and reduce our weighting.

December also saw SA centric stocks being bolstered by the victory of Cyril Ramaphosa in the December ANC presidential election. The election was a muchanticipated political event and had an immediate positive impact on the Rand, thus contributing to the strong returns. The domestic economy appears more conducive for growth under new the leadership and as such we have increased our exposure to Clover, City Lodge, Hudaco and Zeder.

Metair hosted a site visit and strategy update in Turkey. Management have highlighted higher expected battery volumes along with strong margin growth in the current financial year. Operating margin improvements from the FNB and Automotive components divisions are expected to add to earnings. Furthermore, the entity remains highly cash generative and thus, a core holding in the fund.


