



FUND OBJECTIVE & STRATEGY

The Future Titans Prescient Fund has a flexible mandate to invest in a range of asset classes but will typically have high exposure to companies outside of the Top 40 Index. The fund is permitted to invest 25% offshore plus an additional 5% in Africa. The primary objective of the fund is to achieve real long-term capital growth ahead of CPI + 6%. The fund looks to acquire fast growing, mispriced, mid-and small-cap shares, "Future Titans", on the back of high conviction fundamental investment calls. The fund has a deep value / activist bias.

WHO SHOULD INVEST

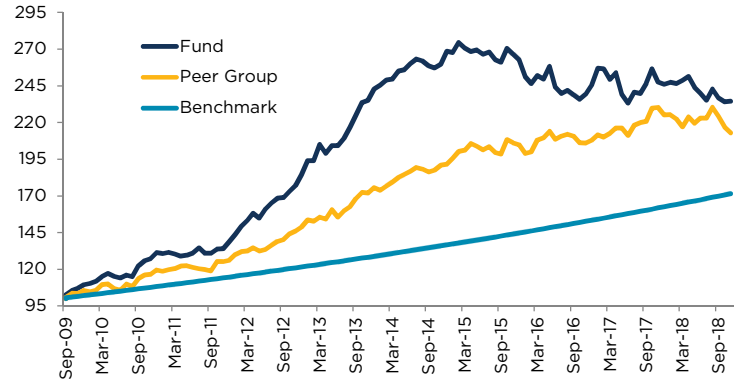
The fund is a high risk, high return fund and should be invested in as a complementary investment to any long-term blue-chip portfolio.

MONTHLY COMMENTARY

November was a tough month with the JSE All Share down 3.29% and resources down 11.88%. Future Titans fared significantly better with a positive 0.19% return.

Clover announced more interested parties had approached them after publishing a cautionary in the prior month. We would expect at least another 25% upside from the current price. Interwaste buyout details have been announced and there is a further 11% uplift in the price until payment on the 4th of March 2019. Both Clover and Interwaste are at maximum weightings of 5% in the fund.

We have been flagging the deep valuation at Metair for some time. Value Capital Partners have now taken a 10% holding at Metair and we would expect some board changes to unlock value. The price has moved from a low of R14 in late October to R19.14 by the end of November. Metair will be a beneficiary of the growing use of batteries, particularly in solar applications where for example their Kenyan business sells 50% of capacity into solar applications.

We continue to believe several of these South African businesses will be the target of foreign purchases due to the extremely low valuations.

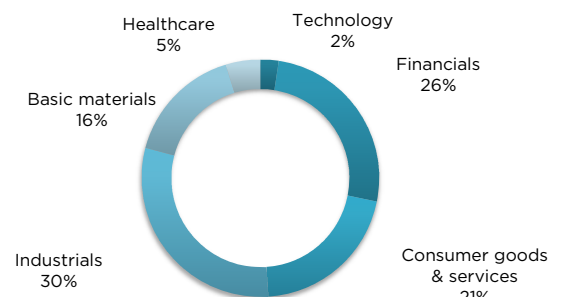
