



FUND OBJECTIVE & STRATEGY

The Fund aims to generate income in excess of money market rates combined with modest capital growth by investing in a range of fixed income assets including cash, NCD's, preference shares, government and corporate bonds and inflation-linked bonds. The Fund may hold listed property and equity, with weightings limited to the sector classification limits. The Fund aims to generate a gross return of CPI plus 1% - 2% over a rolling 12 to 24 month period whilst having a high degree of capital stability. The average duration of the funds investments will typically be in the range of 2-4 years.

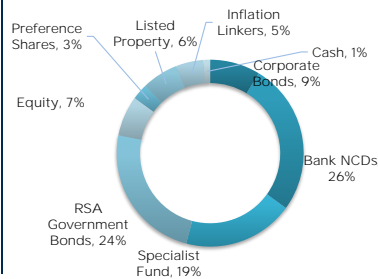

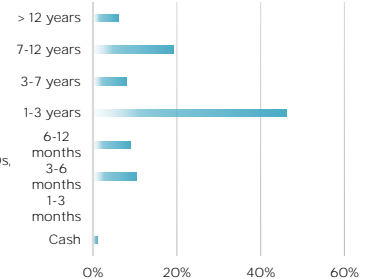

QUARTERLY COMMENTARY | DECEMBER 2023

The fund had a strong finish to the year, ending +1.6% for the month and +5.3% for the quarter to December. For the calendar year the fund has returned +9.3% which is line with the benchmark.

The ALBI enjoyed a very firm quarter adding 8.1% and bringing the total return for the year to +9.7%. Returns within the ALBI we led by the 7-12 year term sub-index, which added +11.9% for the 12 months. Global Bonds were equally strong with the World Govt Bond Index delivering +8.1% (USD) for the quarter and a respectable +5.2% for 2023. The quarter was characterized by a fall of approximately 70 basis points in the US 10-year yield from 4.6% to 3.9% by year end, recouping almost all of the damage incurred during the 3Q.

Central banks remain very watchful of inflation trends, which encouragingly continue to show signs of easing in most economies. Whilst the Federal Reserve kept rates on hold at their December meeting, clearer indications of rate cuts into 2024 were provided. The Fed Funds Rate stands in a range of 5.25% to 5.50%. Our sense is that the specific timing of rate cuts is less important than the trajectory - we are now entering a phase of policy easing. Similarly, the SARB left rates unchanged during the November meeting with the Repo rate remaining at 825 basis points. We are optimistic that we will continue to see more modest inflation trends that ultimately result in lower funding costs for South African economy by the end of 2024.

During the quarter we made a limited number of changes to the fund. We sold our entire position in the I2029 inflation-linked bond and used the proceeds to increase the weight in the shorter dated inflation linked bond, the I2025. In addition, we used the rally in longer dated nominal bonds to reduce the position in the R209 bond and added to the position in the shorter dated R213 bond. Our view is that the current asset allocation is well positioned to meet the funds' stated objective of generating real returns of CPI plus 1%-2%.

The duration of the fund is slightly lower than the prior quarter at 2.46 years with a gross running yield of 9.1%. The Fund has adhered to its policy objective. The number of participatory units at 31 December 2023 was 139 497 975. The current asset allocation versus the previous quarter is as follows:

During the phase in period TER's do not include information gathered over a full year.

Transaction Costs(TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.
