



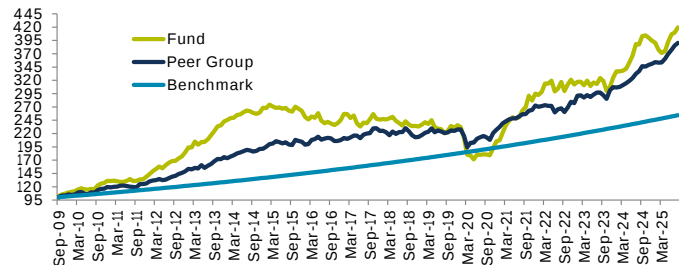
FUND OBJECTIVE & STRATEGY

The ClucasGray Future Titans Prescient Fund has a flexible mandate to invest in a range of asset classes but will typically have high exposure to companies outside of the Top 40 Index. The fund is permitted to invest 25% offshore plus an additional 5% in Africa. The primary objective of the fund is to achieve real long-term capital growth ahead of CPI + 6%. The fund looks to acquire fast growing, mispriced, mid-and small-cap shares, "Future Titans", on the back of high conviction fundamental investment calls. The fund has a deep value / activist bias.

WHO SHOULD INVEST

MONTHLY COMMENTARY

It has finally happened - on the same day as Grindrod announced results, the Minister of Transport announced the 11 names who have been given slots in the rail reform process. Of the 11 names, Transnet Freight Rail is one that we can ignore, and only two others (being MSC, Mediterranean Shipping Company, and Menar) have balance sheets which will allow them to make the necessary investments. These new entrants will first try to lease the "B Class" locomotives from Transnet Engineering. Locomotives are classed as B when they are deemed unfit for Transnet Freight operations. While time and money will be needed to enable many of these locomotives to be rebuilt, this will still be quicker and cheaper than a new USD3m locomotive with a delivery time into South Africa of between 24 and 36 months. This leaves Grindrod with a small fleet of locomotives and wagons to start operations on the Belfast to Maputo corridor moving coal for Exxaro. Outside of owning locomotives the next big hurdle is training staff, drivers receiving the necessary hours on the line they will drive, acquiring workshop facilities and staff who work on locomotives, negotiating port access and receiving a Railway Safety Regulator license to operate. Grindrod Rail has fortunately been in the industry for decades and has all of these requirements covered. Grindrod will start small and start to ramp up purchases of new locomotives as the business model is proven to the board. If you would like further information on rail reform you will find a YouTube video under the heading "Grindrod rail reform". Whilst rail reform will take some time to gather momentum and benefit the economy the positive outlook for GDP and employment into the future is very encouraging. As for their results, Grindrod delivered a flat earnings result for core port and logistics which underscored the large recovery in volumes in Q2 which management have indicated carried over into Q3. This good operational performance together with a special dividend to shareholders delivered a fantastic month for Grindrod which climbed 36% in August.

The fund accepted the offer for MAS Real Estate at a significant premium to the ruling price and will look to rebuild the position in the future as the largest shareholder will unlock the significant value highlighted in the NAV.

As rail reform benefits the entire South Africa we hope to see this reflected in other SA Inc companies we hold in Future Titans.

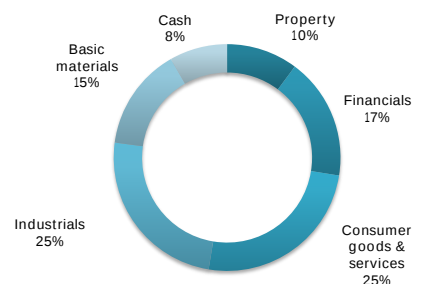
