MONTHLY COMMENTARY

Global risk assets extended their rally in August, with the MSCI All-Country World Index advancing 2.5% and the Bloomberg Global Aggregate bond index rising 1.5% as a combination of resilient business surveys, soothing inflation readings and corporate profits that comfortably exceeded analysts' muted expectations, buoyed sentiment. The most market moving data of the month were lower than expected U.S. non-farm payrolls and a softer consumer price release, which prompted Fed Chair Jerome Powell at Jackson Hole to acknowledge that the balance of economic risks had shifted, driving markets to price in a high probability of a 25 basis point rate cut in September.

In equities, developed markets led gains, with Japan's TOPIX rallying more than 4.5% in Yen terms after a U.S. and Japan trade agreement bolstered exporters and machinery orders surprised to the upside, and the S&P 500 climbed 2.0% as nearly three-quarters of its constituents beat second-quarter earnings estimates - even as an MIT study dampened the near-term revenue impact of AI pilot programmes.

Europe's performance was more nuanced as the MSCI Europe ex-UK Index rose 1.2% on upbeat Eurozone PMIs and loan growth, but French stocks lagged on political uncertainty following a no-confidence motion, and the UK's FTSE All-Share underperformed at 0.9% amid hotter than forecasted inflation and a relatively hawkish Bank of England stance that tempered expectations for further rate cuts.

Emerging markets eked out a 1.5% return, supported by China's pledge to triple chip supply by 2026 and an extension of the U.S - China trade truce through November, while small-cap and value segments outperformed growth, with MSCI World Value outpacing growth by nearly two percentage points as investors grew slightly more cautious on the lofty valuations in technology names despite Nvidia's second-quarter beat.

In fixed income, investment-grade credit led the way with approximately a 1.2% gain in the Bloomberg Global Aggregate Corporate index as spreads tightened on earnings beats and dovish Fed expectations. U.S. Treasuries returned 0.9% and the yield curve steepened when rate-cut odds weighed more heavily on short maturities than longer maturities, high-yield credit posted modest gains on supportive PMI data and strong corporate fundamentals, and emerging-market debt advanced on softer dollar dynamics and the prospect of lower U.S. rates.

Currency markets reflected the U.S. policy pivot, with the dollar weakening nearly 2%, which further boosted non-U.S. asset returns, while oil and natural gas prices declined as reciprocal tariffs and modest supply relief outweighed geopolitical tensions. Gold continued its ascent on falling real yields and demand for hedges against policy uncertainty.

Looking ahead, we believe that although the global growth backdrop remains constructive and corporate fundamentals are sound, equity valuations trade above long-run averages and persistent trade-related tariffs pose upside risks to inflation.

The top-performing securities during the month were United Health, Novo Nordisk and Deckers Outdoor with the biggest detractors being Intuit, Emerson Electric and Evolution AB.
