



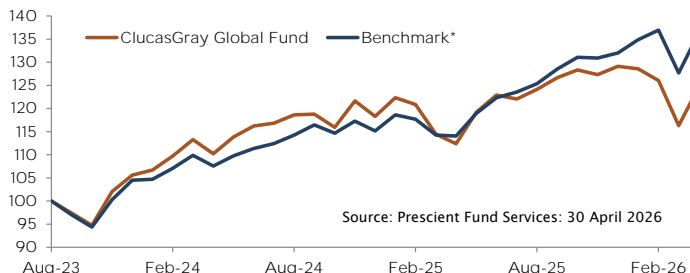
FUND OBJECTIVE & STRATEGY

The investment objective of the Fund is to provide long term capital appreciation and income growth through investment in a concentrated portfolio of assets. The fund is primarily exposed to a focused portfolio of developed market equities. The fund is managed on the basis of the long term ownership of assets and has a bias towards high quality ideas. Investors with a time horizon of three to five years are ideally suited to this fund.

MONTHLY COMMENTARY

The ClucasGray Global Fund rebounded 7.3% in April, while the Morningstar Aggressive Allocation peer group returned 6.8%.

Following March's volatile geopolitical backdrop – in which an escalation of the Iran conflict drove a sharp spike in oil prices and a steep sell-off in global risk assets – April saw a marked de-escalation in tensions, with a temporary ceasefire agreement providing the catalyst for a relief rally across global markets. US equities led the recovery (S&P500 +10.4%), while European (Stoxx 50 +7.3%) and Asian markets (TOPIX +8.2%, Shenzhen CSI300 +9.1%) also participated strongly.

On a sector basis, Information Technology (+19.5%) led gains, supported by an extraordinary 28.3% surge in Semiconductors as AI-related capital expenditure from hyperscalers continued to underpin demand. Software & Services (+5.5%) participated to a lesser extent, amid lingering concerns over AI disruption. Traditional defensive sectors such as Consumer Staples (+2.7%) and Healthcare (-0.1%) lagged amid the broader risk-on move, while Energy (-1.3%) declined as oil prices traded back from recent highs.

The Fund's top-performing holding in April was Broadcom (+34.9%). The company's Q1 earnings reinforced its position as the leading global supplier of bespoke AI chips. Hyperscale cloud players Alphabet (+33.8%) and Amazon (+27.3%) both rallied as cloud revenue growth accelerated meaningfully in the first quarter. Schneider Electric (+19.1%), a key supplier of data centre electrification infrastructure, recovered the previous month's losses. The principal detractors from Fund performance included Intuit (-10.1%), which remained caught up in the software-sector overhang. Healthcare services companies HCA Healthcare (-8.2%) and McKesson (-5.8%) extended their declines into a second month, giving back some of their earlier outperformance as investors rotated out of defensives.

During the month, the Fund initiated a new position in Stryker, the global leader in robotic-assisted orthopaedic surgery. Stryker is a best-in-class operator with a track record of delivering above-sector growth.

The Fund remains fully invested, with a month-end equity exposure of 99.7% and 0.3% in cash.



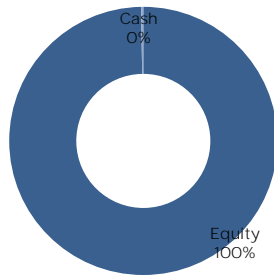

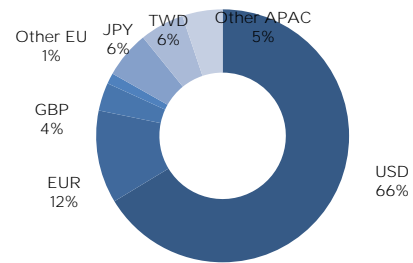

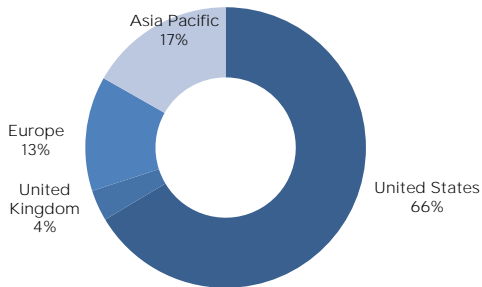
FUND ASSET ALLOCATION



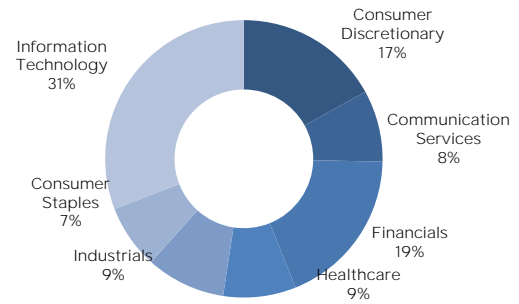
NET CURRENCY EXPOSURE

DISCLAIMER

During the phase in period TER's do not include information gathered over a full year.

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Months: The percentage of months since inception where the Fund has delivered positive returns.
