



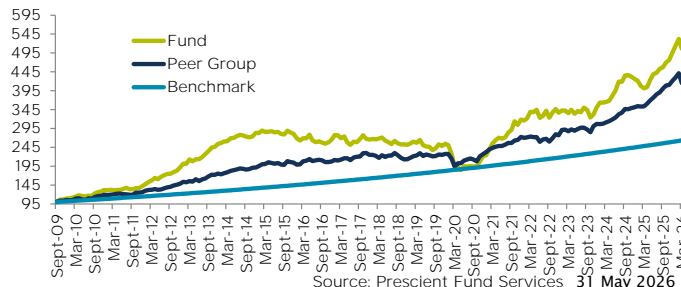
FUND OBJECTIVE & STRATEGY

The ClucasGray Future Titans Prescient Fund has a flexible mandate to invest in a range of asset classes but will typically have high exposure to companies outside of the Top 40 Index. The fund is permitted to invest 25% offshore plus an additional 5% in Africa. The primary objective of the fund is to achieve real long-term capital growth ahead of CPI + 6%. The fund looks to acquire fast growing, mispriced, mid-and small-cap shares, "Future Titans", on the back of high conviction fundamental investment calls. The fund has a deep value / activist bias.

WHO SHOULD INVEST

MONTHLY COMMENTARY

The ClucasGray Future Titans Prescient Fund was up 3.58% for the month, with the Flexible index up 0.18%. The two wars continue to impact our market, with precious metals making up 18% of the JSE. Russia has been selling large gold holdings to finance their planned 3 day invasion which is now a 1,562 day war at the time of writing. Turkey has also been selling down their gold holdings to support the Turkish Lira as the country is a large oil importer. As the Iran conflict drags on, the concern in the market is around rising inflation and interest rates. It's not only oil that has spiked but fertiliser, sulphur, aluminium and all plastic products and packaging. The good news is that we should see significant falls in these products when the Strait is fully opened, allowing inflation and interest rates to fall. All non-oil producing countries are desperate for an opening of the Strait of Hormuz but it is becoming apparent that most of the gulf countries and the USA are beneficiaries of higher oil prices and that dampens the incentive to end the blockade. Consider for example Saudi Arabia which was exporting 6.7m barrels a day during 2025 at c.\$68 a barrel. With the Strait closed, Saudi Arabia is exporting 5m barrels a day through the East-West Pipeline at a premium of \$15.50 above the Oman/Dubai oil price of \$94. Despite exporting less oil, Saudi Arabia (as an example) is better off by \$92m per day.

Reunert delivered a very disappointing set of results, due to weak electrical power cable demand from municipalities and surging copper prices. The defence business, however, delivered strong earnings with further growth expected as Reunert has signed a JV with defence company CSG in Europe to produce artillery fuzes in Europe to NATO standards. In addition, Reunert's CBI business continues to export millions of circuit breakers to the USA which are consumed in the large data centre projects. Defence and electrical component businesses trade at high multiples globally, driven by insatiable demand, and we expect the new management team at Reunert to focus on these high growth opportunities and unlock the vast opportunities at Reunert.

The three top performers during the month were Grindrod on news of the final sign off on private rail access, AECl as the market rerates the company relative to its global competition and Altron after delivering a very strong earnings growth of 34%.

We live in hope that conflict is resolved in Russia and the Middle East, enabling lower oil prices and interest rates which would provide a boost to our economy.

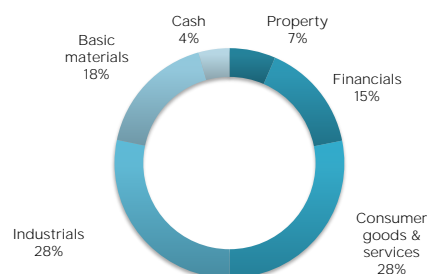
