



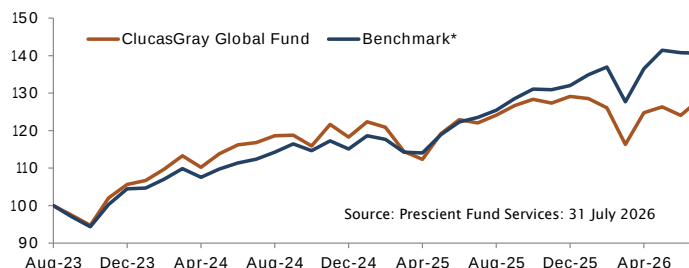
FUND OBJECTIVE & STRATEGY

The investment objective of the Fund is to provide long term capital appreciation and income growth through investment in a concentrated portfolio of assets. The fund is primarily exposed to a focused portfolio of developed market equities. The fund is managed on the basis of the long term ownership of assets and has a bias towards high quality ideas. Investors with a time horizon of three to five years are ideally suited to this fund.

MONTHLY COMMENTARY

The ClucasGray Global Fund rose 3.4% in July, while the Morningstar Aggressive Allocation peer group fell 0.1%.

July's equity performance was defined by a sharp pullback in the artificial intelligence (AI) trade and a broadening of returns into the parts of the market that have been left behind year-to-date.

The MSCI All Country World Index was flat over the month, with significant leadership rotation beneath the surface. On a sector basis, Semiconductors fell 13%, with sharp drawdowns in high-flying memory and storage names (Micron Technology -28.7%, SK Hynix -30.0%, SanDisk -46.6%) where stocks were priced for perfection after extraordinary year-to-date gains. Software & Services (+12.3%) benefitted from the AI rotation but remains deep in negative territory for the year. The broadening was also evident across other sectors with Energy (+12.1%), Financials (+6.2%) and Consumer Discretionary (+3.1%) recording strong gains, while Industrials (-1.7%) and Utilities (-1.4%) – both sectors a downstream play on the AI trade – lagged.

The Fund's top-performing holdings in July were concentrated in the software names that had detracted most in the first half of the year: Microsoft soared 24.6% after reporting standout quarterly results that saw growth in its Azure cloud business accelerating to 43% year-on-year. Intuit (+21.1%), Autodesk (+20.5%) and Salesforce (+17.5%) all rebounded as money flowed back into software. Thermo Fisher (+14.6%) also advanced after delivering a clean second-quarter beat and raise. The principal detractors were ASML (-18.1%) and TSMC (-15.4%), which gave back part of an exceptional run despite both reporting outstanding results that showed demand for AI chips remains robust.

During the month the Fund exited its position in AB InBev after a strong year-to-date rally moved the share price well above our fair value. The Fund also executed partial switches: reducing NVIDIA in favour of Broadcom within Semiconductors, and trimming Booking Holdings while increasing the position in Apple.

At the end of July, the Fund held underlying equity exposure of 97.9%, with 2.1% in cash.



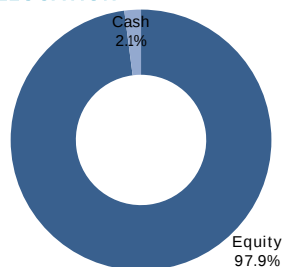

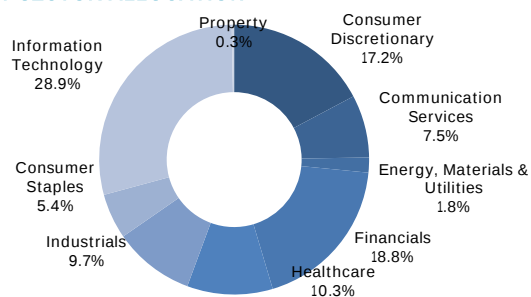

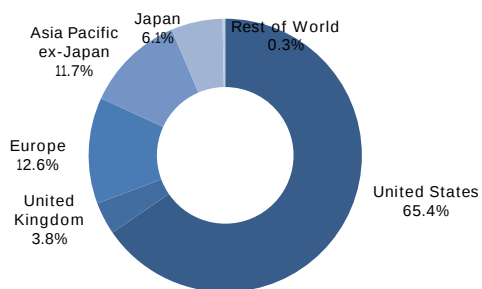
FUND ASSET ALLOCATION

Transaction Costs(TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Months: The percentage of months since inception where the Fund has delivered positive returns.
