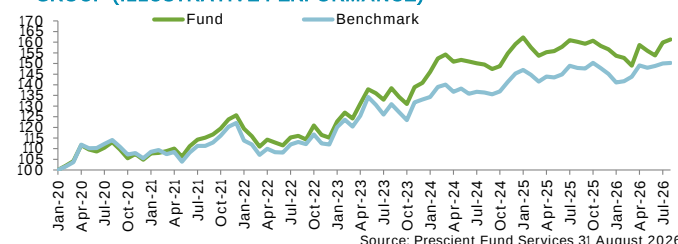


**FUND OBJECTIVE & STRATEGY**

The Fund will employ asset and geographical allocations to reflect changing economic and market conditions to maximise returns over the long term.

MONTHLY COMMENTARY

Global equity markets regained their footing in August, with developed and emerging market indices posting broad-based gains as corporate earnings continued to impress and economic data held up better than feared. The rally was capped by another blowout quarter from Nvidia, which reported \$96 billion in quarterly revenue — more than double the prior year — and forecast continued strong AI chip demand, reigniting risk appetite across the technology complex. Unlike July's rotation into value, August saw a broader-based advance: growth and value stocks rose in tandem, software names such as Salesforce and Adobe led a rebound in technology after last month's sell-off, and small caps also outperformed as business activity surveys pointed to a resilient global economy.

Central bank policy and inflation data dominated the macro conversation. In the US, the Federal Reserve held the fed-funds rate at 3.50%-3.75%, but Chair Kevin Warsh struck a hawkish tone at the Jackson Hole symposium, warning that inflation remained "too high" and that further rate increases could not be ruled out; July's CPI print, released mid-month, showed headline inflation at 3.4% year-on-year and core inflation at 2.5%. In the Eurozone, the ECB left its deposit rate unchanged at 2.25% following June's hike — its first in three years — but flash CPI data showed inflation accelerating to 3.3% in August (from 2.9% in July), its highest reading since 2023, firming up market expectations of a further hike at the September meeting. The Bank of England similarly held its Bank Rate at 3.75%, with UK CPI ticking up to 2.9% in July from 2.6% in June on higher household energy bills, keeping the door open to further tightening rather than the cuts markets had priced in earlier in the year.

Regional equity performance was broadly positive. The S&P 500 added 2.7% in August, buoyed by resilient earnings and the Nvidia print, even as mega-cap technology performance stayed uneven. Japan's TOPIX rose 3.9% in local currency terms, helped by a softer yen and continued AI-related capex spending, while the Nikkei gained 2.9% in dollar terms. European markets were more mixed, with the DAX up 3.3% and Euro Stoxx 50 up 1.9% in dollar terms, though continental government bond markets came under pressure from the hawkish ECB backdrop. Emerging markets outperformed, with MSCI Emerging Markets up 3.4% and MSCI EM Asia up 3.3%, supported by a weaker dollar; Taiwan's chip-heavy market led gains while China's rebound from July proved short-lived as fresh activity data pointed to continued domestic demand weakness.

Fixed income markets were more mixed than equities. The Bloomberg Global Aggregate Bond Index returned a modest 0.5% in dollar terms. UK Gilts posted modest gains and US Treasuries were little changed, while continental European government bonds sold off as the ECB's hawkish stance pushed the German 10-year Bund yield to a fresh cycle high near 3.3%. Japanese government bonds were the weakest performer, with the 10-year JGB yield climbing to a multi-decade high near 2.95% as markets brought forward Bank of Japan rate-hike expectations. Commodities rallied broadly: gold surged 9.7% to a fresh record above \$4,400/oz, supported by a softer dollar, continued central bank buying and market chatter about currency "debasement" following an unexpected US Treasury announcement to expand its long-bond buyback programme; platinum gained 9.0% and Brent crude rose 7.0% to end the month at \$90.49 a barrel, still shadowed by tensions in the Middle East.

Our top performing shares during the month were Salesforce, Samsung Electronics and Evolution with the biggest detractors being Deckers, Heineken and Broadcom.

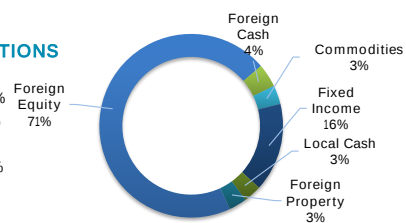

During the phase in period TER's do not include information gathered over a full year.

Transaction Costs(TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Months: The percentage of months since inception where the Fund has delivered positive returns.
